# COMPREHENSIVE PLAN PUBLIC HEARING

Committee Recommendations to be presented to the Public

The Comprehensive Planning Steering Committee and Village Board of Trustees will be holding a Public Hearing to formally present their recommendations to Village residents on Wednesday, November 29 at 7:00 PM at the Voorheesville Fire House

A group of dedicated volunteers has been working for nearly a year on developing a Comprehensive Plan for the Village of Voorheesville. The Draft Comprehensive Plan is available for review on the Village's website <a href="www.villageofvoorheesville.com">www.villageofvoorheesville.com</a>, or on paper at Village Hall and at the Library. Please take some time to look through the plan and give us your thoughts. At the November 29<sup>th</sup> Public Hearing (7:00 PM at the firehouse), our planning consultant, Nan Stolzenburg from Community Planning & Environmental Associates, will present the Draft Plan and the Committee will receive comments. In addition to the Public Hearing, you can submit your comments in writing to the Village Office, or by emailing us.

The Comprehensive Plan will serve as the road map to guide the Village Board in the Village's future growth and development. It expresses the vision, goals strategies and policies to the Village over the next 10 - 15 years. The Draft Comprehensive Plan was developed with the input of many Village residents and business owners through focus groups, our public workshop and a Village-wide survey.

# NEW TRUSTEE APPOINTED

After serving 3 years, Village Trustee Flo Reddy resigned her seat effective September 30. She indicated she has enjoyed the experience of being a Trustee but would like to free up more time to spend with her family and their activities. Mayor Conway has appointed Sarita Winchell to complete the term.

While growing up, Sarita and her family frequently visited her grandparents on their farm in Voorheesville. When she and her twin (Lydia Tobler) graduated from college in 1971, they moved into that same house and she has lived there ever since. Sarita married her husband John in 1972, completed a masters in Economics at SUNY Albany, and worked at General Electric. She began working at the Voorheesville Central School Business Office two years later, first as Treasurer, and for her last nine years as the Assistant Superintendent for Business. She also completed



30 credits in Educational Administration at UAlbany to qualify as a school district administrator. Sarita retired in 2011 but loved the job so much she agreed to fill in 2014 and again in 2015 when the need arose for an interim to head the Business Office.

Sarita has 2 daughters, Lynette and Katherine. She notes that she is greatly interested in local history as her paternal family goes back to the original settling of this area. She is an active member of the New Scotland Historical Association, and a member of the local Methodist Church. She is also serving as a member of the Village's Comprehensive Plan Steering Committee. Her greatest pleasure, though, comes from spending time with her grandchildren.

Sarita says she has a strong love of this area, and looks to a positive future for Voorheesville. She believes that realistic planning for the future will set the Village apart from other communities as we move forward.

# **DPW NOTES**

This newsletter is an opportunity to remind our residents of fall and winter DPW issues.

**LEAVES**: Curbside leaf pick-up will continue as long as the weather allows. Please rake your leaves to the curb, not into the roadway. Keep rocks out of your leaf piles; they cause excessive wear & tear on the leaf vacuum resulting in additional repairs. Help keep storm water flowing: rake leaves and debris away from storm drains.

**BRUSH/STICKS:** Brush pick-up ended back in mid-September. Please do not put larger limbs and brush at the curb at this time. Bundles of sticks, no longer than 3 ft. in length and tied together, will be picked up.

**LAWN BAGS:** If you choose to bag your lawn debris and smaller sticks we will continue to collect these bags.

**SNOW REMOVAL**: When the time finally arrives, please DO NOT shovel or snow blow snow back into the street. This practice is dangerous for drivers who have to drive through the snow.

**PORTABLE BASKETBALL HOOPS:** Portable basketball hoops are to be removed from the street or shoulder areas, especially in cul de sacs. DPW will not be held liable for any damage done to these hoops while doing our jobs.

**VILLAGE RIGHT-OF-WAY:** Mailboxes, trees, shrubs or other items located within the Village's ROW that are damaged by snow and ice removal are not the responsibility of the Village. In the majority of cases damage is caused by the force of the snow being pushed up off the road and is beyond the control of the driver.

# FROM CODE ENFORCEMENT

# CO<sup>2</sup> Detectors and Smoke Detectors

It is now a New York State law that every residence have a CO<sup>2</sup> detector installed. They are available at a wide array of stores and in a wide range of prices. Also, make sure your smoke detectors are working properly. Batteries should be changed twice a year.

# **Tips for Reducing Stormwater Pollution**

### Vehicle and Garage

Use a commercial car wash or wash your car on a lawn or other unpaved surface to minimize the amount of dirty, soapy water flowing into the storm drain.

Check your car, boat, motorcycle, and other machinery and equipment for leaks and spills. Make repairs as soon as possible.

Clean up spilled fluids with an absorbent material like kitty litter or sand; don't rinse the spills into a nearby storm drain. Remember to properly dispose of the absorbent material.

Recycle used oil and other automotive fluids at participating service stations. Don't dump these chemicals down the storm drain or dispose of them in your trash.

### Lawn and Garden

Use pesticides and fertilizers sparingly. When necessary, use these chemicals in the recommended amounts. Avoid application if the forecast calls for rain; otherwise, chemicals will be washed into your local stream.

Select native plants and grasses that are drought and pest-resistant. Native plants require less water, fertilizer, and pesticides.

Sweep up yard debris, rather than hosing down areas.

Compost or recycle yard waste when possible.

Don't over water your lawn. Water during the cool times of the day, and don't let water run-off into the storm drain.

Cover piles of dirt and mulch being used in landscaping projects to prevent these pollutants from blowing or washing off your yard and into local waterbodies.

Vegetate bare spots in your yard to prevent soil erosion.

## **Home Repair and Improvement**

Before beginning an outdoor project, locate the nearest storm drains and protect them from debris and other materials.

Sweep up and properly dispose of construction debris such as concrete and mortar.

Use hazardous substances like paints, solvents, and cleaners in the smallest amounts possible, and follow the directions on the label. Clean up spills immediately, and dispose of the waste safely.

Store substances properly to avoid leaks and spills.

Purchase and use nontoxic, biodegradable, recycled, and recyclable products whenever possible.

Clean paint brushes in a sink, not outdoors.

Filter and reuse paint thinner when using oil-based paints. Properly dispose of excess paints through a household hazardous waste collection program, or donate unused paint to local organizations.

Reduce the amount of paved area and increase the amount of vegetated area in your yard. Use native plants in your landscaping to reduce the need for watering during dry periods.

Consider directing downspouts away from paved surfaces onto lawns and other measures to increase infiltration and reduce polluted runoff.

# Pet Care

When walking your pet, remember to pick up the waste and dispose of it properly. Flushing pet waste is the best disposal method. Leaving pet waste on the ground increases public health risks by allowing harmful bacteria and nutrients to wash into the storm drain and eventually into local waterbodies.

# **Swimming Pool and Spa**

Drain your swimming pool only when a test kit does not detect chlorine levels.

Whenever possible, drain your pool or spa into the sanitary sewer system.

Properly store pool and spa chemicals to prevent leaks and spills, preferably in a covered area to avoid exposure to stormwater


