This addendum consists of 1 page and 6 pages of attachments. The following additions, deletions, and modifications are made to the Bidding and Contract Documents for the project.

Addendum No. 1 includes a clarification on Section 004513-Bidder Qualifications related to providing qualifications related to similar project work. Only paragraph 5 (Page 2) is revised, but all of Section 004513 is updated in this addendum.

Specifications:

1. 004513- Bidder Qualifications. On Page 2, under Paragraph 5, clarified to read “List three (3) or more projects that the Bidder has completed in the past ten (10) years that includes installation of HDPE pipe (greater than 6-inches in diameter) by horizontal directional drill methods for a length that exceeds 1,000 feet.”
 - a. Bidders who fail to meet the Bidder Qualifications in Section 004513 are not considered to meet the qualifications for the project.

This addendum is hereby made a part of the Bidding and Contract Documents. Bidders are advised to acknowledge the receipt of this addendum on page 004100 - 1. Failure to do so may invalidate the Contractor’s bid.
